Understanding the GB Power Market

Training course

Delivered in collaboration with LCP Delta, this training course focuses on financing power stations, generating electricity and trading across markets.

It offers a detailed understanding of the main power markets (Wholesale Market, Balancing Mechanism, Ancillary Services, Capacity Market and Contracts for Difference), a breakdown of power asset costs and revenue (CapEx, OpEx and O&M), network charging and building the business case for a new asset.

This training course is aimed at those who:

- Are joining the energy industry as an experienced hire
- Have good working knowledge of the energy industry and want to add knowledge of electricity markets
- Have already attended our 'Introduction to GB Energy Markets' training course

The objective is for attendees to gain:

- Understanding of how power is generated and traded
- An overview of key trends as the GB electricity supply decarbonises
- Understanding of recent policy interventions and their goals
- Knowledge of the UK generation portfolio and how decarbonisation changes the markets
- Awareness of future developments in the market, such as Dispatchable Power Agreements (DPAs)
- Understanding of the challenges facing transmission and distribution networks and the application of network charges
- Understanding of how forecasts are used to build the business case for different types of generation assets

When the Brexit Transition Period came to an end on 31 December 2020, changes were made to current trading electricity and gas arrangements.

This one-day intermediate training course will provide an overview of the way electricity, gas and carbon are traded in GB and across borders to/from neighbouring markets, with a particular focus on the way that these have changed following the end of the Brexit Transition Period.
